*** Full payment for single sessions or packages of sessions is expected prior or at the first session.**

*** 24 hours prior notice is required for client to reschedule any appointment sessions free of charge.**

Any appointment postponed by client or *Wagtime Pet Sitting & Dog Training llc* with 24 hour prior notice, will be rescheduled at a mutually agreed upon future date & time.

No show by client for scheduled session appointment without giving 24 hour prior notice client's account will be automatically charged or deducted for the value for that particular session.

Any charges or deductions for cancellations given with less than 24 hours notice are at the discretion of *Wagtime Pet Sitting & Dog Training llc*, not to be greater than the value for that session.

*** Unused sessions of purchased a package of sessions have an expiration date without refund.**

All packages of sessions expire after 4 months from date of purchase.

***Cancellation & Refunds:**

Client may CANCEL continuation of contracted dog training services at anytime for any reason.

To receive a refund on any prepaid fees, client must cancel this dog training agreement & contract by notifying *Wagtime Pet Sitting & Dog Training llc* in writing to **9155 SW 124 Street, Miami, FL 33176**.

Refund check will be sent via US postal service to client's address on this contract within 10 business days from receipt of client's written notice of cancellation.

Refund for unused sessions will be **based on single session fees** for the specific training service client has contracted for on the front of this agreement form, less any processing fees.
